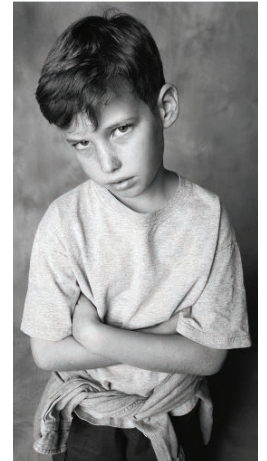




Every year, more than three million children nationally are abused or neglected. Despite the state's attempts to help, many of these kids become trapped in the court and child welfare maze and can spend their childhood moving from one temporary placement to another.

Unfortunately, nationally there are more than 700,000 abused and neglected children who aren't experiencing a full happy childhood and are in protective custody. Two hundred of those children are in Knox County. The children are worrying about court hearings, adjusting to new placements, and transitioning to new schools.
